[Paragraph 2]

1. Preparations formulated for agricultural use, namely, fertilizers, pesticides, fungicides and herbicides.

- 75 of 1999. 2. Animal feeding stuff suitable for any live bird, fish, crustacean, mollusc or other animal of a kind generally used as, or producing, food for human consumption or for any draught animal.

- 75 of 1999. 3. Seeds and other means of propagation of plants that are used for providing either food for human consumption or a feeding stuff referred to in item 2 above.

- 75 of 1999. 4. Crop dusting services.
